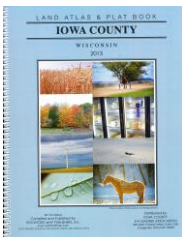

SWINE PROJECT CHANGES TO IDENTIFICATION AND THE FAIR AUCTION

New for 2014:

- Adults will not be driving from farm-to-farm to identify Iowa County Fair swine.
- Youth must self-identify their swine for the Iowa County Fair.
- Youth must submit identification photos and the appropriate paperwork for their swine to the Extension office by June 1, 2014 in order to exhibit at the Iowa County Fair.
- The Iowa County Fair will be a terminal show for **all** swine. All swine that are exhibited will go to market; no swine can be taken home from the fair.
- There will be a market gilt show on Thursday night of the fair. Check the Fair Book for details.

Youth enrolled in the swine project received a packet of information from the Extension Office which included the Iowa County Fair swine self-identification information.

ATTENTION GOAT EXHIBITORS

There will be 2 educational goat classes this year – it is MANDATORY to attend 1 class to exhibit at the county fair. 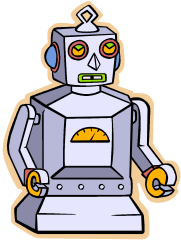
MAQA (Meat Animal Quality Assurance)

The Meat Animal Quality Assurance program (MAQA) is a Wisconsin-developed program that teaches quality assurance practices to meat animal project members. **Anyone who plans on showing market hogs at Iowa County or Wisconsin State Fair MUST be MAQA certified.** The Extension Office will offer MAQA certification sessions on **June 18 from 1-3 pm, and July 10 from 1-3 pm & 7-9 pm**. All swine exhibitors who need to be certified or re-certified need to attend one of these MAQA programs in order to exhibit at the fair. To register for an MAQA session, CONTACT THE EXTENSION OFFICE AT 930-9850 OR muffy.swingen@iowacounty.org. **Youth MUST register in advance to attend a MAQA Session.**

Swine project members in grades 3-13 need to be MAQA certified every year. However, youth who are in the intermediate age group (age 12-14, grades 6-8) or the advanced age groups (ages 15-18, grades 9-13) have the option to “test out”. Testing will take place one hour prior to each learning session. Youth who plan to “test out” must pre-register with the Extension Office. The “test out” option does NOT qualify as an educational program. Contact Lisa Schlimgen for more information about the “test out” option. In order to test-out youth must be 12 years old by January 1 of the current year.

LIVESTOCK SHOW CAMP

The 2014 Wisconsin Junior Livestock Show Camp is scheduled for June 14-15th, at the Wisconsin State Fair Park in West Allis. This two-day camp is for beef, sheep and swine project youth interested in learning or perfecting showing and fitting techniques, livestock management and evaluation, and meeting new friends involved in the livestock industry. A unique aspect of this camp is the ability for parents to attend the camp with their child for a more effective learning experience, especially for younger exhibitors. Registration deadline is May 15, 2014.
