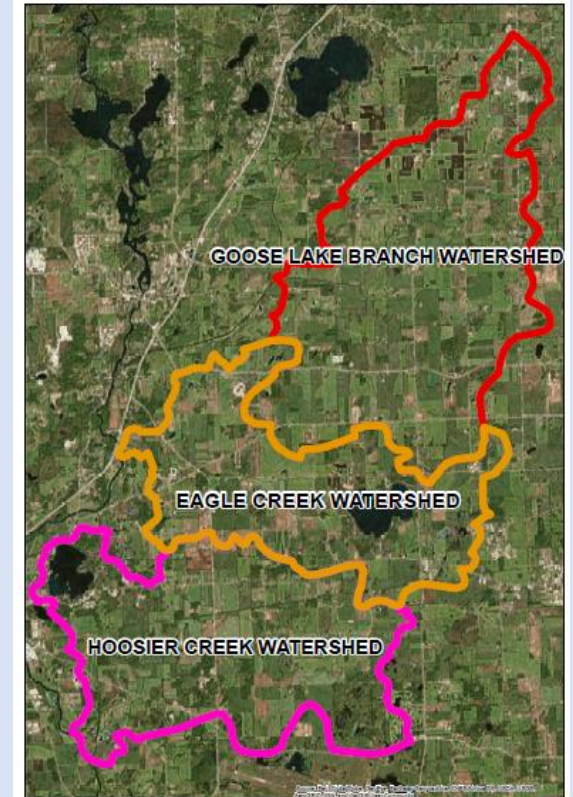
This field day is FREE, but you must pre-register by August 29th to attend!
