

## Risk Management Programs

- **Dairy Price Risk Management—Thursday, February 11<sup>th</sup>**  
**Lena Town Hall: Starting at 10:00am**

We will be focusing on the tools you have available as dairy producers to conduct milk price risk management. Details of how to use those tools correctly, their true costs, and what you are actually going to accomplish with them. Discussion will include all the available possibilities from simple forward contracting to the futures market, and how the MPP-Dairy or LGM-Dairy programs interact with your risk management. We will work through examples of using different methods and do 'practice' marketing to see how the methods compare. Will include broker and producer perspectives on these tools.

- **Crop Insurance for 2016—Thursday, February 18<sup>th</sup>**  
**Oconto Falls Community Library: Starting at 1:30pm**  
**Free—Coffee and Snack Provided**  
 Join Scott for a discussion of the crop insurance programs for 2016 crop production. Although there aren't lots of new things, there are always tweaks to the system and considerations for your decision-making as we approach the March 15 deadline. In particular, we'll be looking at ways to have sufficient coverage, but without having excess premium costs. Discussion of the new whole-farm products available for small or highly diversified farms will take place toward the end of the workshop, so feel free to stop in at 4 p.m if your farm fits into these types of insurance products.

 Unfortunately, the blunt approach to marketing grain from 2015 and 2016 production is that we need to minimize losses, unless we see a significant, long-term weather event. There are certain cycles to the grain marketing year that any crop producer can take into account to help them plan out their grain marketing strategies. This can be especially true in a lower grain price climate. We will be concentrating on the grain price annual cycle and how to put a plan into place through which you make sound decisions that take emotion out of your pricing decisions. In the process,

we will analyze the different pricing or protection tools that you can use in your marketing plan.

One step of proper marketing is knowing your cost of production, so we will start the day with a review of different methods for estimating 2016 cost of production. Having an understanding of your costs will allow you to make better, more confident decisions regarding pre-harvest pricing opportunities.

## Annual CAFO Meeting Green Bay—February 12<sup>th</sup>

This is the annual update meeting for WPDES permitted farms and all the consultants that work with them. If your farm is on the verge of WPDES permit size or you are wondering about some of the logistics of post-permit management, you may want to consider attending.

## Florence Farm Management Update

A farm management update meeting will be held on Thursday, February 25 at the Florence Natural Resource Center starting at 11:30 am with registration and a light lunch. Agencies (FSA, NRCS and LWCD) will be present to discuss updates and opportunities in 2016. A presentation at 1:30pm will discuss crop costs in 2016 followed by a focused issues discussion on major issues facing Northern Wisconsin agriculture and future field research projects.
