INSTRUCTIONS

If exhibiting more than one species - a separate form for each species is required. Examples:

- If you are exhibiting both Beef (Dept. 2) and Poultry (Dept. 7), two forms required; one for each species.
- If you are exhibiting both Dairy (Dept. 1) and Beef (Dept. 2), two forms are required; one for each species.
