We are partnering with the Land and Water Conservation Division of the Washington County Planning and Parks Department to support the “Trees and Prairie Program.” Through this program we will learn about trees and how the Land and Water Conservation Division serves the public with trees that will help the environment and keep nature thriving in our community.

Where – Washington County Fair Park – Small Animal Building

We have included the waiver and signup sheet for you to review. To make the program work, we need volunteers ages 12 and older and adults with each group. There is a minimum age requirement because volunteers need to be able to handle large packages and some heavy orders. Instructions will be delivered by the Land and Water Conversation Division staff at the event. We ask that you dress for cool weather, and you may also get damp and dirty.

You will have the opportunity to learn about the Washington County Tree Program, learn about different kinds of trees, how to plant trees and more. It is also a great way to support other Washington County departments.

1. Hereby waives, releases, forever discharges and covenants not to sue Washington County, the Washington County Planning & Parks Department, its agents, employees, volunteers, and any duly authorized representative thereof (hereinafter "Releasees"), from all liability for damages, injuries, claims, loss or expense which the Participant may incur while participating in the above referenced program/activity, whether caused by the negligence of the Releasees or otherwise.

2. Hereby agrees for the Participant, any heirs, administrators, executors and assigns, that the Participant shall indemnify and hold harmless the Releasees from all liability for damages, injuries, claims, loss or expense to the Participant or their property whether caused by the negligence of the Releasees or otherwise.

3. Understands that participating in the "Tree Program" may be dangerous to the Participant (e.g., may involve heavy lifting, carrying & sorting of bare root tree/shrub seedlings on wet concrete flooring). Participant expressly and specifically assumes the risk of injury or harm in this activity and assumes all responsibility for losses, costs and damages that may be sustained or incurred as a result of participating in this activity.
