2nd Annual All-Breeds 4-H Formal

Hosted by: Winnebago County 4-H Dairy Project

When: Friday, August 4, 2017 at 7:30 p.m. Winnebago County Fair Grounds, Covered Arena

Who: Open to all junior exhibitors of all breeds in Winnebago County. Exhibitors 12 years and under may show a calf (spring, winter or fall), and exhibitors ages 13 and up may show a yearling (summer, spring, winter or fall).

Purpose: The 4-H Dairy Futurity is meant to encourage dairy project members of Winnebago County to gain industry experience by giving incentives for making comprehensive management decisions with their dairy project animals. It also encourages the exhibition of more mature heifers, giving the project members a complete project experience with the same animal for at least one year. The 4-H Dairy Project and the Dairy Futurity provide opportunities to expose participants to potential careers in the dairy and agriculture industry.

Procedures: An animal is nominated by its owner or handler and all nominations are the responsibility of the owner or handler. All animals and exhibitors are required to compete in the junior breeds show at the Winnebago County Fair.

Prizes: Prizes will be awarded to the class winner through 10th place, Best Dressed male and Best Dressed Female. Payout of Purse will be determined based on number of animals exhibited.

Refunds: When nomination fees are paid they are committed to the purse and refunds will not be made, whether or not the animal is shown or its eligibility is discontinued by the owner.

Dress Code: Exhibitors must be in formal dress to show in the Futurity. Minimum requirements for men include: shirt, tie and dress pants; for women: at least a knee-length dress, business suit or equivalent. Exhibitors must wear closed toed shoes. Above the knee skirts, dragging trains and open toed shoes are strictly prohibited. Exhibitors not meeting the minimum dress code requirement will be denied entry into the Showing.

Release of Liability: Every precaution will be taken to properly protect animals and exhibits in this show. The management and the Winnebago County Fair Association, however, will not be liable for the safety of animals, exhibits, exhibitors or their employees, or for losses sustained because of robbery, damage by fire, accident or any other cause.
